	a) Earth Day Tree Giveaway <ul style="list-style-type: none"> Steve and Jess submitted the application for 400 tree seedlings. A recent response from the State could not confirm that we will receive all 400 seedlings requested. The seedlings will likely be picked up by DPW and will be given out on Saturday, 4/24/2021 from 9 a.m. to 11:30 a.m. at Grove Park. Social distancing and masks will be required. Jessica will ask Steve to form a registration sheet for residents who would like seedlings. Registration will be on a first-come, first-serve basis. Apart from the residents who attend to pick up seedlings, we will create a general invitation ad for social media to publicize our cleanup. Sean and Mike will invite various scout organizations for collection of natural items to construct a mythical model house. 	<ul style="list-style-type: none"> The event will occur, subject to NJ Health code updates or restrictions on or about 4/24/21. Jess will ask if we can have mulch delivered for the garden, if needed. Jess will send Mike the copy for the web ad. Sean and Mike will invite the various scout organizations. Update at our April meeting.
	b) Verona Recycling Videos: <ul style="list-style-type: none"> Contributors will choose from a list of common mistakes residents make in recycling and produce a short 1- to 2-minute video using their own cell phones. Most common mistakes include plastic bags, cleanliness of bottles, cans; bottle caps; only plastic 1, 2, and 5, directives to flatten cardboard and keep it dry; explain chipboard and give examples of it with mixed paper, and discuss specialty materials like oil, tires, e-waste collections, shredding events and hazmat. Another idea was to simply walk your street with the camera and take video of obvious mistakes you see on your walk. 	<ul style="list-style-type: none"> Kari, Sarah, Mike and Christen are interested in creating videos. Jess sent the list of common mistakes to the contributors and they will communicate with each other from here on in. Update next meeting.

	<p>c) Sustainable Verona Update: Frank/Kari</p> <ul style="list-style-type: none"> ○ The ordinance on Community Garden was passed by the Council and new funding was offered by an additional charity. The Landsberger donating \$10k, which will likely be used for tables with chess and checkers board on the tabletop. ○ Today, 20 beds were placed in their locations. More wood is needed for completion of all beds. ○ The ribbon cutting event is scheduled for 3/19/2021 at 11 a.m. ○ Sustainable NJ Actions for attaining a Bronze status were discussed. ○ Energy Aggregation Program held their presentation and new media for further public understanding will be shared on social media. ○ SV is moving forward with the TREX program. After a certain amount of plastic is collected, the town can receive a TREX bench which would fit well at the new community garden. ○ Educational Recycling videos plans have been altered. 	<p>a) Stormwater Ordinance</p> <ul style="list-style-type: none"> ○ The Stormwater Ordinance was discussed by the Council at a Special Meeting on 2/17/2021 and introduced at the 2/22/2021 meeting. ○ The Ordinance was passed at the 3/8/2021 meeting by a vote of 5-0. ○ The VEC sent a memo to the Council on 2/17/2021 that listed items it thought imperative to include in the Ordinance. Most of the items were adopted in the final ordinance. ○ The major differences between our draft and the State Model include lower thresholds for the definition of major development, applicability to all major developments and redevelopments, an emphasis on the use of green infrastructure as a means of stormwater control, maintaining stormwater on site, and the addition of mitigation requirements on minor developments. ○ The Ordinance was not inserted into our Zoning Code; an action which the VEC felt would aid in compliance of all properties throughout the township. ○ MOTION to approve Memo on Stormwater Ordinance Recommendations by the VEC: Sean; Second: Fuad. ○ APPROVAL: All Members Present AYE. 	<ul style="list-style-type: none"> ● VEC PRC letter was emailed to the Town Council prior to this meeting. ● No actions necessary.

	<p>a) Leaf Blowers (Gas-powered).</p> <ul style="list-style-type: none"> o The VEC is researching the possibility of sending a memo to the Town Council that would recommend certain restrictions on commercially-used, gas-powered leaf blowers. o Many nearby municipalities restrict commercial use to seasonal months: summer through mid-fall of each calendar year. o Other municipalities also limit hours of operation, allowing for gas powered leaf blower use from 8:30 a.m. on weekdays and at 9 a.m. on weekends until 5 p.m. all days. o Members agreed that, at this point, no restrictions should be placed on residential use of gas-powered leaf blowers. o Members all agreed that they would like a memo sent to the Council for consideration of an ordinance to address this matter. 	<ul style="list-style-type: none"> • Jess asked Martin to begin a draft memo, including a statement of purpose and to send to Jess and Sean. • Jess and Sean may finalize it and forward a memo to the Town Council and Manager. • Update next meeting.
